All India Institute of Medical Sciences, Vijaypur, Jammu is a Central Autonomous Body (CAB) established by an Act of the Parliament under the *Pradhan Mantri Swasthya Suraksha Yojana PMSSY* division of the Ministry of Health and Family Welfare, Government of India.
