The quotations duly signed, sealed and marked as **“SRE No.24/RPC/GSK/2014-15” (PRICE BID & TECHNICAL BID separately)** should reach the office of the Stores Officer, Room No. 180, 1st Floor, Dr. R.P. Centre, AIIMS, New Delhi-110029 on or before **07.07.2014 up to 11.00 A.M.** All quotations should be typewritten or written with indelible ink. All over writing and erased entries will not be considered and treated as deleted entries from the quotations. The rates should be valid at least for one year.

The tenderers are required to deposit security of **Rs. 5,000/=** (Rupees Five thousand only) through a Demand Draft/Pay Order drawn in favour of the **“Chief DR. R.P. Centre, AIIMS, New Delhi”** before opening of the quotations, failing which the quotation will not be considered. In case of failure to comply with the supply order in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the supply order should be specified.

The firm has to quote for **one best quality only** and only sample of that particular quality (if possible) should be submitted along with lab. Test report (if required). **The offers will be submitted in two separate sealed covers i.e. price bid and technical bid separately.** The offers submitted in one sealed cover and for quality A, B, C & D etc. will summarily be rejected. The quoted items having quality mark such as ISI/CE Mark/ISO 9001-9002 standardization (if any) should be mentioned clearly.

The quotations/tenders (**technical bids only**) will be opened on **07.07.2014 at 11.30 AM** in the office of Stores Officer, Room No. 180, Dr. R.P. Centre, AIIMS, New Delhi-110029 in the presence of the tenderers, whosoever are present.

 - a. All S.S. Top 1.6mm thick S.S. non magnetic sheets beat downwards.
 - b. Vertical member 1.6mm thick 30mm diameter non magnetic S.S. pipe.
 - c. Lower shelf 1.6mm thick S.S. Bent upward.
 - d. **Castors:** Four castors, Heavy duty, pressed sheet chrome plated 3mm thick, 100mm diam. With rubber bonded wheels, with needle roller.
 - e. Bush type bearings.
 - f. Railing: On the type shelf on 6mm dia S.S. rod on three sides (width & one length) 3” above each shelf.

- 2. Instrument Trolley(Size Height: 820mm, Length 900mm, Width 475mm) – 02 Nos.**
 - a. All S.S. Top 1.6mm thick S.S. non magnetic sheets beat downwards.
 - b. Vertical member 1.6mm thick 30mm diameter non magnetic S.S. pipe,
 - c. Lower shelf 1.6mm thick S.S. Bent upward.
 - d. **Castors:** Four castors, Heavy duty, pressed sheet chrome plated 3mm thick, 100mm diam. With rubber bonded wheels, with needle roller.
 - e. Bush type bearings.
 - f. Without Railing.

- 3. Push Cart Trolley: (Overall size L 24”, W 24” & H 32”) - 03 Nos.**
 - a. Frame work made up of 25mm round M. S. Pipe
 - b. Mash size in inch 1”x1”
