Nursing (4 years) course from any recognized University, from an education institution recognized by the State Nursing Council, with 60% marks for General/OBC/EWS candidates (55% marks in case of SC/ST candidates) in aggregate in the qualifying examination.
	Registration as a Nurse, RN, RM (Registered Nurse, Registered Midwife) with any State Nursing Council.
	Candidates working at AIIMS, New Delhi, should submit their applications through the proper channel, i.e., the Establishment Section, AIIMS. The applicants from the AIIMS Nursing Staff/Nursing Tutor Cadre will be required to submit a "No Objection Certificate" before they are allowed to take the entrance examination of the M.Sc. Nursing Course at AIIMS, New Delhi. Secondly, they need to take study leave from the concerned Establishment Section before joining the course, as it is a two-year full-time M.Sc. Nursing Course.

Other Rules & Regulations	Each student shall be required to undertake a dissertation on a selected research topic. Other rules applicable to other MSc courses in the other department will apply, such as that the Chief Guide must be from the College of Nursing, and the Co-Guide may be from other related departments.
