- 1. The Wet Lab Management Committee will provide overall guidance, policy, and regulations for running the Wet Lab in association with the administrative set-up of the SET Facility.
- 2. The day-to-day management of robotic training facilities will be under the purview of the Robotic Simulation Training Subcommittee. All robotic surgery training platforms will be installed in the wet lab of the SET facility. The other surgical training programs of the Wet lab will be under the purview of the Surgical Simulation Training Subcommittee.
- 3. The SET facility is equipped with many expensive training resources including manikins, endoscopes, energy sources, robotic platforms etc. It also uses resources such as cadavers, tissues, and manpower. Prudence is required in the use of these resources.
- 4. All training programs conducted in the SET facility should follow the existing AIIMS guidelines for organization of Conferences etc. (copy attached). Training programs that require the use of expensive equipment/resources such as manikins, endoscopes, robotic platforms, cadavers etc. should primarily be conducted for AIIMS faculty/students/staff/trainees.
- 5. If programs are conducted for non-AIIMS trainees, the SET facility should recover the costs incurred on the acquisition and maintenance of these equipments unless specified by the appropriate authorities/MOUs. The Wet Lab management committee of SET facility should prepare a list of approved use and user charges for such programs.
- 6. Events conducted in collaboration with or under the aegis of independent societies or bodies should be limited and monitored to prevent the use of AIIMS facilities for profit generation. All financial aspects of such events must follow the procedures and rules described for 'Departmental Events' at point 12 in the Guidelines for Organization of Conferences etc. (attached).
- 7. The SET facility should enable online booking of its facilities and create a calendar showing the booking status of various facilities.
