**Abstract Submission Guidelines:** Participants willing to submit abstract should follow the following guidelines. Abstracts should be written in English. Abstract should not exceed 300 words. It must be prepared in MS Word format. A 12 point font, Times New Roman, 1.5 line spacing should be used. Abstract should be structured one with following sub-headings indicating in bold - Background; Objectives; Methods; Results; Conclusion. Please define abbreviations and acronyms including standard measures.

We encourage applying through mail for the convenience the participants, so abstract can be emailed to [ahpcon2016@gmail.com](mailto:ahpcon2016@gmail.com) The submitted abstract will be reviewed by the expert committee of related profession and the authors will be notified about the acceptance by Email. If accepted for oral presentation the selected author will be invited and informed by 30<sup>th</sup> January, 2016 to present the scientific paper/lecture in conference.
