Sub: Immediate transfer of Nursing Informatics Specialist (NIS) from Computer Facility to various patient care areas reg.

Ref. OM No. 40-30/2025-Estt.I dt. 06.12.2025, it had been directed that all the NIS attached to the Computer Facility & performing non-patient care duties, be posted in patient care areas in a phased manner and alternative IT support staff be engaged on outsourcing basis to handle any IT related functions.

The said support staff has now joined in the computer facility and is managing the various IT support functions earlier performed by NIS.

Accordingly, it is desired that all NIS posted in the computer facility be transferred to various clinical areas by 28th February 2025. To ensure continuity of any managerial responsibilities currently handled by the NIS, it is preferable that the NIS are posted against the nursing strength of the same Centre / Hospital / Block wherein they are currently working and based on the functional requirement, the administrative incharges of the respective area can decide on their work assignment.

OFFICE MEMORANDUM

Sub- Shifting of Nursing Informatics Specialist (NIS) from Computer Facility to various patient care areas.

The undersigned is in receipt of multiple requests from various clinical areas regarding the requirement of Nursing Officers for enhanced patient care. During interactions with various hospital stakeholders, it was observed that there is a growing need for Nursing Officers in recently commissioned patient care areas.

To achieve the highest level of patient care at AIIMS, the Nurse-to-patient ratio needs to be improved to ensure excellence in patient care. Accordingly, it is directed that all the NIS attached to the Computer Facility & performing non-patient care duties, be posted in patient care areas in a phased manner by 31st January 2024. To fill the gap created due to shifting of NIS from Computer Facility to various patient care areas, approval may be sought to engage appropriate Information Technology (IT) human resources for Computer Facility on outsourcing basis.
