## कार्यालय जापन

**विषय: मरम्मत एवं नवीनीकरण कार्यों से संबंधित गतिविधियों हेतु इंजीनियरिंग यार्ड संबंधी।**

दिनांक 01.06.2023 के का.जा.सं. 40-30/2022-स्था.। के संदर्भ में, यह निदेश दिया गया था कि एम्स, नई दिल्ली में काम करने वाले सभी इंजीनियरिंग ठेकेदारों के लिए ट्रॉमा केंद्र परिसर में एक 'इंजीनियरिंग यार्ड' बनाया जाए ताकि वे साइट की आवश्यकताओं के अनुसार अपना सामान तैयार कर सकें - जैसे पत्थर काटना, लकड़ी का काम, वेल्डिंग, आदि - और फिर इन सामानों को एसेंबल करने/फिट करने के लिए नॉक डाउन अवस्था में निर्माण स्थल पर ले जाया जाए। ऐसा यह सुनिश्चित करने के लिए किया गया था कि निर्माण स्थल पर कोई भी धूल भरा या शोर पैदा करने वाला कोई बड़ा काम न किया जाए ताकि वायु प्रदूषण को कम किया जा सके, गलियारों, वार्डों आदि में पड़े इंजीनियरिंग मलबे से रोगियों एवं कर्मचारियों को असुविधा से बचाया जा सके तथा कायाकल्प पहल के तहत एम्स, नई दिल्ली के स्वच्छ वातावरण को बढ़ाया जा सके।

अधोहस्ताक्षरी द्वारा हाल ही में आवासीय क्षेत्रों सहित पूरे एम्स परिसर का दौरा किया गया और नोट किया गया कि मरम्मत एवं नवीनीकरण कार्यों के लिए वेल्डिंग, पत्थर की कटाई, लकड़ी की कटाई/ग्राइंडिंग आदि का काम अभी भी निर्माण स्थल पर किया जा रहा है और सारे कच्चे माल को वहीं संसाधित किया जा रहा है। इसे बहुत गंभीरता से लिया गया है और यह एम्स, नई दिल्ली में संक्रमण नियंत्रण एवं प्रदूषण शमन के उच्चतम मानकों के अनुरक्षण के लिए हानिकारक है।

तदनुसार, यह निदेश दिया जाता है कि दिनांक 7 अप्रैल 2025 तक अधोहस्ताक्षरी के कार्यालय में इंजीनियरिंग यार्ड निर्माण की कार्रवाई रिपोर्ट एवं वर्तमान स्थिति प्रस्तुत की जाए।


**Sub: Engineering Yard for activities related to repairs & renovation works reg.**

Ref. OM No. 40-30/2022-Estt.I dt. 01.06.2023, it had been directed that an 'engineering yard' shall be created in the Trauma Centre Campus for all engineering contractors working at AIIMS New Delhi to prepare their items as per site requirements - like stone cutting, woodwork, welding, etc. – and these items shall then be transported to the construction site in a knock down state to be assembled / fitted therein. This was done to ensure that no major dust or noise producing works are done at the construction site so as to reduce air pollution, avoid inconvenience to patients and staff from the engineering malba lying in corridors, wards, etc. and to enhance the clean environs of AIIMS New Delhi under the Kayakalp initiative.

The undersigned has taken rounds of the entire AIIMS campus including residential areas recently and has noted that welding, marble cutting, wood cutting / grinding, etc. for repair and renovation works is still being done at the construction site and the entire raw material is being processed therein. This has been viewed with great concern and is detrimental to the maintenance of highest standards of infection control & pollution mitigation at AIIMS New Delhi.

Accordingly, it is directed to submit action taken report & current status of the engineering yard construction to the office of the undersigned by 7<sup>th</sup> April 2025.

**OFFICE MEMORANDUM**

**Sub: Engineering Yard for activities related to repairs & renovation works reg.**


The undersigned has noted that marble cutting, wood cutting / grinding, etc. for repair and renovation work across AIIMS Delhi Campuses is leading to a lot of noise & dust pollution in the patient care & public areas. This is also causing inconvenience to patients and staff alike as the engineering malba is lying in corridors, wards, etc. and is also spoiling the clean environs of AIIMS New Delhi.

Accordingly, it has been decided that a temporary covered 'engineering yard' shall be created in the Trauma Center Campus by 31<sup>st</sup> July 2023. The said 'engineering yard' shall be a centralized place for all engineering contractors working at AIIMS New Delhi to prepare their items as per site requirements - like stone cutting, woodwork, welding, etc. – and these items shall then be transported to the construction site in a knock down state to be assembled / fitted therein. No major dust or noise producing works shall be done at the construction site once the said engineering yard is made operational.

Further, for the welfare of construction workers and labourers, the engineering yard shall be made all weather and well ventilated. There should be facility of drinking water, toilets, etc. nearby and the space shall be maintained by the engineering department regularly. Provision of water, electricity, etc. if required to facilitate the works therein shall also be made by engineering department.

The engineering department shall also ensure that all repair / renovation works are finished within 15 days. To ensure the same, all engineering contracts should specify the minimum number of workers that need to be deployed and use of modern tools, technology & methods to expeditiously finish all works with minimal dust / noise pollution should be encouraged. Also, the contractors must ensure that the engineering site is properly cordoned off and all measures prescribed to ensure safety of staff, public & workers are implemented in spirit.
