To further augment the said dashboards, it is desired that a time stamp be displayed on all pages and in cases where the data is being fetched on real-time basis, the same be clarified therein.

Also, Department wise statistics should be displayed for all Departments in a tabulated form with absolute numbers and not just in percentage.

Sub: Integration of waiting time of services in the AIIMS 'patient care dashboard' : info.aiims.edu

As a part of Good Governance & to increase transparency, AIIMS New Delhi's patient care statistics & analytics are being displayed on the AIIMS website as an AIIMS 'Patient Care Dashboard' (info.aiims.edu) (OM No. 40-30/2022-Estt.I dt. 04.11.2022)

To enhance transparency, it has been decided that the said patient care dashboard shall be augmented to pro-actively display the waiting list statistics for various services at AIIMS New Delhi, including waiting for:

- General Ward bed allocation
- Private Ward allocation
- Day Care Services
- Surgical Services
- Laboratory Tests including specialized tests
- Imaging Modalities including Radiology & Nuclear Medicine
- Therapeutic Services like LINAC, Brachytherapy, etc.

The computer facility shall build in the said functionality on the patient care dashboard and the respective departments shall update the waiting statistics for the aforementioned services on a daily basis.

**Sub: Starting of AIIMS 'Patient Care Dashboard' on [info.aiims.edu](http://info.aiims.edu) reg.**

As a part of Good Governance & to increase transparency, it has been decided to share AIIMS New Delhi's patient care statistics & analytics on AIIMS website in the form of an AIIMS 'Patient Care Dashboard'. This dashboard will have the following details:

- Real time Summary bed status of all general & private wards
- Realtime Emergency Patients Admission & Waiting status
- OPD Footfall status – Daily & Monthly footfall of new & follow up OPD patients
- Radio diagnostics status – Daily & Monthly statistics of X-ray, Ultrasound, CT Scan, MRI, DSA, etc
- Nuclear Medicine diagnostics status – Daily & Monthly statistics of PET Scan, SPECT Scan, etc.
- Laboratory Diagnostics Status – Daily & Monthly statistics of all lab tests done at AIIMS
- Radiotherapy Status – Daily & Monthly statistics of all procedures done on LINAC & Brachytherapy
- OT Utilization – Daily & Monthly statistics of number of surgeries performed in all OT's across AIIMS
- Day Care Procedures Status – Daily & Monthly statistics of number of endoscopy, chemotherapy and other major day care procedures done at AIIMS

Dr Vivek Gupta, Addl. Prof. of Community Ophthalmology & Dr Kanika Jain, Asst. Prof. of Hospital Administration shall be the nodal officials responsible for designing, commissioning & updating the AIIMS 'Patient Care Dashboard'. All departments are required to provide them the necessary support and cooperation in this initiative.

The said dashboard shall go live on the National Good Governance Day i.e. 25<sup>th</sup> December 2022 & shall be accessible to the general public via [info.aiims.edu](http://info.aiims.edu)
