Sub: Comprehensive maintenance, cleaning & odour control in common patient & staff toilets at AIIMS New Delhi reg.

The undersigned has taken extensive rounds of clinical and administrative areas of AIIMS New Delhi as a part of the ongoing Swachhta Pakhwada, during which it has emerged that the most common dissatisfier for patients is the maintenance, cleanliness and odour control in common toilets at AIIMS New Delhi.

The issue has been further examined and it is understood that currently the maintenance of toilets is done by the Engineering department while cleaning and sanitation is done by the outsourced agencies as per their contracted areas. It is also noted that the staff deployed by outsourced agencies are not scientifically trained in cleaning & odour control in toilets and are hence unable to keep the toilets clean and odour free.

Accordingly, it has been decided that as a part of the Swachhata Campaign, a comprehensive contract shall be executed for the maintenance, cleaning & odour control in the patient & staff toilets at AIIMS New Delhi to ensure the highest quality of cleanliness & sanitation therein. As and when the existing sanitation contract for a specific area shall lapse, the toilets in that areas shall be covered under the new comprehensive maintenance, cleaning and odour control (MCO) contract and not under the new general sanitation contract.

The MCO contract shall ensure the following for all toilets covered under it:

- Comprehensive repair, renovation & engineering maintenance of the toilets
- Deployment of trained and dedicated manpower for regular cleaning of toilets
- Odour control and aesthetics of all toilets
- User feedback based payment incentive to ensure quality of service
- Strict penal provisions in case of deficiency of service
