



1. This refers to the initiation of Examination Section, AIIMS, New Delhi regarding Commercial Agreement Between Air India Limited and AIIMS, New Delhi for getting front line incentive on Air Tickets booked by AIIMS, New Delhi. For this purpose, as per directive of the Director, AIIMS, New Delhi the Agreement was came into force between Air India and AIIMS, New Delhi w.e.f. 16th April 2016 for one year and from AIIMS, New Delhi it was signed by the Chief Administrative Officer, AIIMS, New Delhi (Annexure-1).
2. It is proud to inform that AIIMS has almost achieved the target of Rs. 1 Cr. and got 6% front line incentive from Air India from 16th April, 2016 to 15th April, 2017.
3. The Agreement has been over on 15th April, 2017 and now it is to be renewed immediately, Accordingly, Air India has submitted the two copies of the Agreement duly signed by the Authorized signatory of Air India to get signed from the AIIMS (Annexure-2).
4. Accordingly, as per previous practice, following are submitted for kind approval:
 - (i) To get signed the two copies of Agreement from the Chief Administrative Officer on behalf of AIIMS, New Delhi.
 - (ii) To disseminate said information through administration to all departments of AIIMS, New Delhi with allocated code so that they may also get the benefit of incentives on booking of air tickets on front line basis from Air India.

The AIIMS, New Delhi has made a Corporate Travel Commercial Agreement with AI last year to avail air travel facility for its employees with discounts and special deals by AI to corporate. The said agreement was over on 18th April, 2016.


As follow up to come in new agreement with AI, a note dt. 25.4.2017 to renew the commercial agreement for getting incentive on the AI tickets issued by him to AIIMS sent to the Director, AIIMS for kind approval along with two copies of proposals. The Director and Dy. Director Administration approved the proposal and on behalf of AIIMS two copies of the agreement were signed by Chief Administrative Officer, AIIMS, New Delhi and the same was sent to Air India for signing from the authorized signatory of Air India. Now, we have received a copy of the Agreement duly signed by authorized signatory of Air India. The Air India has allocated tracking Code D394 and A/C code 451394 (Copy enclosed, Annexure-2).


Keeping in view of the above, the Director, AIIMS may be requested to send the same to the Chief Administrative Officer for further circulation to other departments of AIIMS to enable them to get incentives on Air India tickets from Air India.

As Examination Section has to purchase large numbers of Air Tickets from AIR India through authorized agent for staff of AIIMS, other AIIMS, and Officers of Ministry engaging in the various entrance examination, one copy is being kept in the Examination Section for further initiation in the matter.
