MINUTES OF THE MEETING

Subject: Minutes of the Joint Committee Meeting in the matter of Gaurav Sharma Vs. GNCTD in O.A. No. 202/2023 conducted on 10th May 2024, at 12:00 pm in the Director's Committee Room, AIIMS, New Delhi.

A Joint Committee meeting was convened in the matter of Gaurav Sharma VS GNCTD in O.A No 202/2023 regarding implementation of recommendations of the Joint Committee as per directions of the Hon'ble National Green Tribunal (NGT) under the chairmanship of Director, AIIMS on 10th May 2024 at 12:00 pm in the Director's Committee Room, AIIMS, New Delhi.

At the outset, Chairman welcomed the House and informed that the agenda of this meeting is to take account of the actions taken with reference to the decisions taken in the previous meeting.

The following points were discussed:

1. **Integrated Plan for Traffic Management at AIIMS:** Chairman, Traffic Management Committee informed the House that, as decided in previous meetings, approved road map for traffic management has been strictly implemented, further streamlining of traffic has been done, locations for parikrama and autorickshaws have been designated, necessary signages have been created, and School of Planning and Architecture is requested to review these signages for further inputs if any. Accordingly, Chief Security Officer, AIIMS to submit the pointwise Action taken report (along with relevant photographs) to the Nodal Officer within 48hrs, which will be submitted to Hon'ble National Green Tribunal.

2. **Traffic Management outside AIIMS: Congestion on high volume roads - MG road and Aurobindo Road:**

a. **Relocation of Rehen Basera outside AIIMS:** As decided in the last meeting, a written communication has been sent by the Additional Director, AIIMS to the Chief Executive Officer, Delhi Urban Shelter Improvement Board, requesting for relocation of Rehen Basera outside AIIMS to an alternate location. Their response is awaited. The Chairperson desired that a written communication be submitted from Delhi Police to the Chief Executive Officer, Delhi Urban Shelter Improvement Board requesting them to refrain from establishing Rehen Basera outside AIIMS in future.

b. **Increase in the number of Vehicles including taxis and auto rickshaws parked outside of AIIMS on Aurobindo Marg stretch:** A written communication has been sent by the Additional Director, AIIMS to the Deputy Commissioner of Police (Traffic), South Range, Delhi regarding traffic congestion outside AIIMS gate no.1 & 3 on Aurobindo Marg stretch. It was observed that even after the decision in the last meetings and written communication being submitted to DCP (Traffic), vehicles are still being parked in front of Gate no.1 & 3 and the MCD parking is lying vacant. As decided in the last meeting (with reference to the minutes of meeting) a communication maybe sent from the DCP (Traffic Police) to MCD to allow utilization of the MCD parking and a copy of the same may be sent to Security Officer, AIIMS for information. Representative from Delhi Traffic Police informed that necessary measures have been taken to streamline traffic movement outside AIIMS on Aurobindo Marg stretch. Around 5100 & 700 challans have been imposed for violation of traffic rules since January 2024, through mobile app & E-machines respectively. They also informed that around 600 vehicles parked in unauthorized locations have been towed away during this period. Accordingly, Delhi Traffic Police to submit the point-wise Action taken report to the Nodal Officer within 48hrs, which will be submitted to Hon'ble National Green Tribunal.

c. **Dedicated lane for Ambulance outside AIIMS:** In the previous meeting, Director, AIIMS highlighted the need for provision of a dedicated lane for Ambulance outside gate no 1 of AIIMS on Aurobindo Marg stretch to facilitate convenience of patients

and for addressing traffic congestion outside AIIMS due to unauthorized parking of vehicles and requested Delhi Traffic Police to explore options for provision of a dedicated lane for Ambulance outside gate no 1 of AIIMS on Aurobindo Marg stretch. It was informed by SHO, Delhi Traffic Police, that maintaining a dedicated lane for Ambulance is not feasible, but the lane outside gate no 1 of AIIMS on Aurobindo Marg stretch is being vacated on regular basis.

3. Setting up of AQI monitoring station and GRAP implementation: GRAP is being implemented as per guidelines. Mr. Dinesh Jakhar, EE (Electrical) informed that the work has been awarded for installation of one AQI monitoring station on Shiva Road, and it will be completed by end of May 2024.

4. Traffic Management inside AIIMS:

- a. **Vehicular congestion at entry gates of AIIMS:** The Chairman, Traffic Monitoring Committee informed the House that the previously present vehicular congestion is now circumvented and there is presently no congestion at the entry gates and inside AIIMS.
- b. **Parking of vehicles, taxis and auto rickshaws at undesignated places inside AIIMS:** The Chairman, Traffic Monitoring Committee informed that the deployed QRT has been efficient in removing auto rickshaws (that are operating exclusively within the campus) and parked vehicles from undesignated places leading to overall improvement of traffic inside AIIMS. CSO informed that 6 cranes have been deployed round the clock for towing away of vehicles parked in undesignated places. Around 50 to 60 vehicles are being towed away every day and penalties are being levied to streamline the traffic movement inside AIIMS.
- c. **Monitoring of vehicular traffic entering AIIMS:** Chairman, Traffic Monitoring Committee informed that RFID enabled boom barriers to have already been installed at 5 locations in AIIMS. RFID enabled tags for in-house vehicles have been installed and ingoing and outgoing traffic is being monitored at various entry and exit gates with strictly implementation of RFID policy. It was also informed that automatic number plate recognition cameras are being installed at various entry and exit gates to track real time stay of vehicles inside premises of AIIMS. This will ensure responsible stay of vehicles entering AIIMS premises.
- d. **Procurement of 200 electric vehicles for transportation of staff & patients:** It was informed that in first phase, 30 electric vehicles of varying capacity will be procured by the Transport Committee at AIIMS. In this regard, ESD informed that the charging points for electrical vehicles have already been installed.

5. Green Belt inside AIIMS:

ESD, AIIMS informed that the following measures have been implemented:

- a. Plantation of 250 trees on either side of shive road connecting gate no.6B and 7 is under process. Response from the Forest Department for provision of trees is awaited.
- b. Plantation of around 50 shrubs along the road connecting gate no.1 and 2 has been completed.
- c. Lawn and Park development in open areas has been completed.
- d. Regular cleaning of horticultural and construction waste lying around in various areas of the premises is being done.

6. Green Belt outside AIIMS:

The Representative of NDMC informed that around 700 small plants and shrubs have been planted along the boundary wall of AIIMS from gate no.2 to gate no.1., and NDMC has made a commitment to replace the plants and shrubs lost due to animal and traffic activity in due course of time.

7. Dust Management at Construction Sites:

ESD informed that all the necessary steps are being taken to meet the dust mitigation norms in AIIMS. As highlighted in the previous meeting that the condemnation area behind Dr. R.P. Center was observed to be unmanaged at most times leading to haphazard placement of condemned materials and incursion of various pests in the area. ESD was requested to get the area cleaned, properly maintained, and ensure any repairs as necessary. ESD is requested to complete the task and to submit an Action taken report.

- 8. Solid Waste Management:** It was observed that solid waste is not being cleared on regular basis around AIIMS, especially outside gate no.2 and in the masjid moth area. NDMC representative submitted that the mentioned area is under MCD. MCD is requested to ensure proper management of solid waste in these areas.

- 9. Illicit activities on foot over bridge and subways around AIIMS:** A written communication has been sent by the Additional Director, AIIMS to the Deputy Commissioner of Police, South District, Delhi regarding illegal activities happening outside AIIMS on Aurobindo Marg stretch including foot over bridge. Delhi Police informed that 2 police personnel have been deployed in the area and trespassers and other unwelcome crowd are being regularly vacated from the foot over bridge regularly. In previous meeting it was also observed that the foot over bridge was looking very shabby due to lack of maintenance from a long period of time. In this regard it was discussed that the Delhi Police may take necessary action and submit an Action taken report of the same to the Nodal Officer of this committee.

- 10. Retrofitting of DG sets:** ESD informed that the process of retrofitting of DG sets involves three distinct activities: installation of fuel kits on the existing DG sets,

installation of gas pipelines and connection of these pipelines to fuel kits. Since DPCC informed that the process of retrofitting would be funded by them, it was decided that a clarification in this regard would be sought by ESD and to initiate the process.

For DG sets installed in community health centers and other centers away from AIIMS, it was decided that the concerned State Pollution Control Boards maybe approached for seeking clarity in the matter of retrofitting.

11. Installation of ETP for the treatment of laundry effluent at AIIMS:ESD informed that the work has already been awarded and is likely to be completed by end of July 2024.

12. Installation of Pollution Mitigation System at AIIMS: ESD informed that 2 units of Pollution Mitigation System has already been installed at AIIMS on trial basis. ESD to submit a brief report on Pollution Mitigation System at AIIMS to the Nodal Officer of this committee.

[Action: ESD, AIIMS]

13. Speed breakers in the premises:Chairman, Traffic Monitoring Committee informed that movable barriers have been installed in various areas of AIIMS to mitigate and optimize speed of traffic.

[Action: ESD, AIIMS]

All concerned stakeholders are requested to comply with the directions of the Hon'ble National Green Tribunal.
