Subject: Blacklisting of M/s Adidev Herbals Pvt Ltd for participation in the tender/bids of AIIMS, New Delhi henceforth-reg

Ref No.GeM 511687742558543 for the purchase of Alcohol based hand rub.

This is to inform you that regarding the procurement of Alcohol-based Hand Rub, bid number 511687742558543, awarded to your firm by JPNATC through the GEM Portal, it has come to the notice that the supplied stock of first lot does not meet the required alcohol content specification. Testing conducted by both in-house laboratories (with the RPC report showing an alcohol percentage between 35-38%, and the trauma center report indicating a percentage between 40-42%) and a third-party NABL-accredited/Government-approved lab (which reported only 10.54% alcohol) has confirmed that the alcohol content falls below the prescribed standards. This non-compliance could adversely impact patient care services.

In light of this, a show cause letter was issued to your firm, and multiple communications were sent with request to withdrawal the remaining stock. Despite these efforts, your firm failed to comply. Additionally, a personal hearing was arranged on 31.07.2024, for which your representative did not attend. A second meeting was convened on 20.09.2024, where an individual, identified as a relative of your authorized representative, attended in place of the designated representative. However, this person could not provide the necessary authorization letter and was unaware of the issue, which further exacerbated the situation.

Such actions not only violate the terms and conditions of the bidding process but also undermine the integrity of the procurement system at AIIMS, New Delhi.

Considering the breach of the code of integrity as outlined in the AIIMS Purchase Manual-2018, Rule 151 of the General Financial Rules 2017, and the guidelines issued vide O.M No. F1/20/2018-PPD dated 02.11.2021 by the Procurement Policy Division, Department of Expenditure, Ministry of Finance, Government of India, it is hereby decided to debar M/s Adidev Herbals Pvt. Ltd. from participating in any future bids issued by AIIMS, New Delhi for a period of two (2) years, with effect from 06.01.2025.

This decision has been made with the prior approval of the Competent Authority.
