Those who will be coming for interview may take note of following:

- Please read the instructions carefully which are mentioned below and make sure that you are fulfilling the eligibility and you have to carry documents in original to support the same at the time of interview.
- Interview letter of those who have been shortlisted, will be available on dashboard after login on [www.aiimsexams.ac.in](http://www.aiimsexams.ac.in)
- You should report for interview on scheduled date of your post, along with interview letter ,copy of online application and all those supporting documents (in original ) with a self attested set of photocopies, which you have been uploaded with online application.

➤ You will be allowed to attend interview subject to following:-

Production of the following certificates/documents in original along-with a copy of each, duly self attested:-

- i. Date of Birth; (10<sup>th</sup>/Matriculation certificate issued by recognized board).
- ii. Caste Certificate (in case of Scheduled Caste/Scheduled Tribe/Other Backward Class)

Candidates applying for positions reserved for SC /ST / OBC / PwBD / EWS categories must submit a valid Caste / PwBD / EWS certificate issued by the appropriate authority in the prescribed format.

**iii.OBC Candidates:** Candidature of all the candidates, apply against OBC category, is PROVISIONAL, subject to production of latest OBC certificate, complying following conditions:

- Candidates applying under the OBC category must submit a valid caste certificate in the format prescribed by the DoPT vide OM No. 36036/2/2013-Estt(Res.) dated 30.05.2014 and further clarified by OM No.36036/2/2013-Estt(Res-I) dated 31.03.2016.
- Eligibility for OBC candidates is determined based on the caste(s) included in the Central List of OBCs issued by the Government of India.
- OBC candidates must not belong to the Creamy Layer and their sub-caste must precisely match with the entries in the Central List of OBCs.
- Failure to meet these criteria will result in their candidature being considered under the UR category (if otherwise eligible and UR posts are available).
- As the vacancies are advertised in the financial year 2024-2025, only NCL-OBC certificates issued between 01.04.2024 and closing date of application will be considered valid. Certificates issued outside this period will be deemed invalid for this recruitment. Candidates without a valid NCL-OBC certificate issued within the specified period will not be considered for posts reserved under the OBC category under any circumstances.



**Note: If any candidate has not uploaded valid OBC certificate issued by the Competent Authority while applying the post, he/she will be allowed to appear for interview . They will be required to submit an undertaking that he/she will submit valid OBC certificate issued in the financial year 2024-25 on or before interview date.**

iv. PWBD Candidate

- Only such persons would be eligible for reservation under PWBD category who have not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to produce a Disability Certificate as issued by a Competent Authority in prescribed format as per "Rights of Persons with Disabilities Act, 2016".
- PwBD applicant's who are found suitable by the selection committee will be evaluated by a Medical Board constituted by the Director, AIIMS, New Delhi. This board will assess the functional suitability of the candidates for the advertised post. Only those candidates who are found to be functionally suitable for the post will be offered the post.

v. EWS candidate

- Candidature of candidates under EWS category will be considered subject to submission of Income and Assets certificate in the prescribed format issued by the Competent Authority and subject to verification of genuinity of the certificate by the issuing authority.
- Candidature who fail to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered as UR candidate, if otherwise eligible.
- EWS candidates must ensure that they possess a valid EWS certificate issued between 01.04.2024 and the last date of application.

vi. Proof of Educational/Professional qualifications as applicable:

- MBBS
- MD/MS or equivalent
- DM/M.Ch. or equivalent
- B.SC./M.Sc./Ph.D. as applicable
- BDS
- MDS or equivalent

In case of those who are holding DNB in broad specialties or super specialty as qualifying education, they have to produce documentary evidence issued by Competent/Appropriate authority about DNB equivalence with MD/MS/DM/M.Ch/MDS; Applicants holding DNB in broad specialties or super specialties as their essential qualifying education must provide documentary evidence of its equivalence with MD/MS/DM/M.Ch.; as applicable .This evidence

must meet the following criteria as per NMC New Delhi notification dated 14.02.2022

DNB training should had been done in a medical institution with an attached hospital or in a hospital with 500 or more beds by the National Board of Examinations.

OR

Candidate has done one year of senior residency in a medical college or institution recognized by NMC as teaching institution for that specialty/superspecialty after passing DNB in the concerned specialty / super-specialty (In all cases where DNB training was done in a hospital with less than 500 beds) Candidates with essential qualification being DNB will be eligible if one is meeting either of the above conditions.

vii. **Experience Certificate:**

Certificate showing that you have possessed the requisite number of years of teaching and/or research experience on last date of online application as prescribed for each post, from MCI/DCI /UGC recognized Institution(s) as per the following terms:

- Teaching/Research experience acquired only after post graduate qualification in the specialty will be considered.
- Those who have DNB as qualifying degree will need to have 1 year extra experience i.e. total 4 years from MCI recognized/permited institution for equivalence if the bed strength of medical institution with attached hospital or hospital granted DNB is less than five hundred (500).
- Teaching experience which will be eligible to be counted for this purpose will be in the concerned specialty from MCI/DCI recognized medical college(in cases where MCI/DCI recognition is from a particular year, experience prior to that will not be considered). Like wise Post Graduate experience in any institution which awards MCI recognized PG degree in the specialty will only be considered valid.

**You are requested to make sure that you have post PG experience which is as per the Recruitment Rules, issued by Head(s) of the Organization / Administration and bring supportive documents(including document from MCI/DCI, if need be) for the same.**

viii. Certificate of registration with Medical Council of India/State Medical Council/Dental council of India/ State Dental Council, as the case may be.

ix. **No Objection Certificate:** No Objection Certificate from the present employer for your appearance for interview in respect of the post applied for and further indicating that in the event of your appointment, you would be relieved in time for joining the post. If the candidates fail to produce the required NOC from his/her present employer he/she shall not be allowed to appear for interview.



[Applicable in case of regular employee, working in Government/Semi or Quasi Government, Government enterprises or Government funded autonomous institutions (Not applicable for contractual employee/ those working in Pvt. Sector)]

- You should to come prepared with a Power Point presentation (CD/Pen drive containing your PPT only) on your work/ major achievements, not exceeding five minutes covering the following aspects (4 slides):-
  - i) First Slide containing your ID No. (Reg. No.) & name only.
  - ii) Service/innovations (one slide)
  - iii) Research/publications (one slide) and
  - iv) Major recognition/awards (one slide)

**IMPORTANT:**(i) Candidates have been called for interview provisionally subject to fulfillment of all the aforesaid requirements as asked for, failing which you will not be allowed to appear for interview under any circumstances.

(ii) Interview may spill over to the next day depending upon the number of candidates present on the scheduled day of interview. Therefore, candidates should be prepared to be available for interview for next day, if necessary.

(iii) If at any stage, it is found that candidates not fulfilling eligibility criteria for the post or any declaration given or information furnished proves to be false or if he/she is found to have willfully suppressed any material, information, he/she shall be removed from service and any other action as deemed necessary by the Institute may be initiated.
