3.	The successful Tenderer shall take delivery of Materials at accepted price. The amount shall be paid by the Tenderer by Crossed Account Payee Demand Draft on any nationalized bank payable in New Delhi drawn in favour of <b>Chief Dr BRAIRCH, Ansari Nagar, New Delhi</b> . The removal of the Materials will be permitted only after payment of full amount and Delivery Order obtained from AIIMS, New Delhi.
4.	All the charges i.e. loading, unloading and transportation to be incurred in course of lifting of items from the designated placed shall be borne by the successful bidder.
