- The firm is requested to mention the make/model of each part(1 to 65)
- If any spare/accessories/consumables other than above mentioned are required during the process of repair & maintenance of said PNG,LPG Gas Pipe line & kitchen Equipment, the same will be borne by the firm only.

General Terms & conditions as under: -

- 1. The firm should have been in the same business for repair & maintenance of PNG/ LPG Gas Pipe Line, LPG Bank & Kitchen Equipments and othersuch equipment for a period of at least 2 years in such type of maintenance contract for which the quotations are being submitted. The firm should have permission/authorization from concerned authority to perform repair & maintenance work of PNG/LPG pipeline.
- 2. A proof of ownership/partnership of the firm should be submitted along with verifiable address of the registered office, telephone number etc.
- 3. The payment will be released quarterly/half yearly/annually on submission of pre receipted bill after getting satisfactory work completion certificate from respective user areas of the hospital and Terms and conditions.

- 4. No advance payment will be made on any account.
- 5. The AIIMS shall not be liable for any type of payments to be made by the firm to the employees deputed at AIIMS.
- 6. AIIMS will not responsible for any additional liability of your staff like PF/ESI or statutory benefit.
- 7. AIIMS will not be liable for any compensation under the workman compensation Act.

8. Penalty clauses:

- The firms are requested to visit PNG/Main Kitchen of AIIMS and after accessing the existing condition of PNG/LPG Gas Pipe Line, LPG Bank & Kitchen Equipments, may quote the AMC charges as per schedule attached herewith. Once the firm is selected, the contention of the firm that some spare part is damaged because of underlying condition of the machine/equipment or for any other reason, whatever it may be, will not be entertained. The firm should clearly mention exclusions in technical bid, if any. Items which are not mentioned in exclusions will be deemed to be covered under AMC. For items excluded, firm should give unit price of each item which they will charge for, if need be. This price information should be in financial bid only. If the replacement of any consumable/items mentioned in above table is violated; the company/firm is liable for penalty of Rs. 500/- per instance along with replacement of the consumable in question free of cost.
- The firm will have to provide preventive maintenance service once in 15 days/bi-monthly and to attend all emergency calls for repair even on Sundays and Holidays. All repairs are to be completed in the shortest possible time and in no situation the down time will be more than 48 hours under any circumstances after lodging written/verbal complaint to the vendor. The vendor is also required to depute their authorized and well qualified technical personal to the work site to resolve all minor problems (if any) on the spot. In case of non-execution of work within the stipulated time, the Director AIIMS, New Delhi will have the right to impose a penalty of Rs. 500/- per day/per machine/equipment which will be deducted from the AMC charges.

In view of the above, all interested and eligible firms/vendors/service providers are informed and requested to submit their quotations for AMC for Repair & Maintenance of PNG/LPG gas pipelines and kitchen equipment at AIIMS, New Delhi at AIIMS, New Delhi at the earliest but not later than 31-10-2024 (05:00 PM).
