Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Commercially available blood culture bottle which should compatible with BD FX 40 automated blood culture system.
2. The culture medium inside the bottle should be ideal for the growth of both Gram positive and Gram Negative bacteria.
3. Each bottle contains a chemical sensor which can detect increase in CO₂ produced by the growth of microorganisms.
4. Bottles should be ready for use as received and require no reconstitution or dilution.
5. The storage of uninoculated bottles can be done at room temperature. Storage temperature [range:2-25](#) degree C.
6. The bottles should contain at least 30 ml of broth and should have the capacity to hold at least 10 ml of blood sample in addition to the culture medium already present inside.

Disclaimer
