Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as per the Order 2017 as amended from time to time and its subsequent Orders/Notifications issued for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated on portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documents shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase documentary evidence submitted, while evaluating the bid. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
