Arthroscopic hand instruments having state of art quality, durability, precise tactile feel & an extremely low profile tip. The instrument should have hinge less design to ensure durability & life time guarantee against manufacturing defect with following features.

PUNCHES

1. 2.5mm-5mm shaft diameter, wide biter 15° up curved shaft, straight tip
2. Medium punch 2.5 mm-5 mm straight shaft, 15° up tip
3. Punch large 2.5 mm-5 mm diameter straight shaft and tip.
4. Punch large 2.5 mm-5 mm straight shaft, 45° Right/Left angled tip.
5. Punch-Rotary with 32.5 mm-5 mm straight shaft, 90° right tip
6. Punch-Rotary with 2.5 mm-5 mm straight shaft, 90° left tip
7. Reverse Punch with 2.5 mm-5 mm diameter, straight shaft, Straight tip
8. Reverse Punch with 2.5 mm-5 mm diameter, straight shaft, 15° up tip
9. Punch Medium with 2.5 mm-5 mm shaft diameter, 100-220 mm, straight tip

Quotations should be sealed in an envelope and the reference no. and item name clearly written on top of the envelope. (i.e. L.T.E No. 23/Ortho/Store/2019-2020/Plan for the General Arthroscopy Instruments. The company should provide whole set of instruments as quoted from a single manufacturer.

1. The firm must be registered and having TIN no. /registration no. and GST No. (Please mentioned TIN/registration no. and GST No. on the bids) or else the quotation will be REJECTED.

The bidder is required to submit bid in two parts viz

(a) Technical Bid in one envelope containing following information.

- i. Technical descriptions of quoted model/s
- ii. List of all consumables/accessories required to run the equipment
- iii. Terms & conditions including warranty/CAMC/Taxes etc.
- iv. Original Catalogues of quoted model/s
