

1.	Integration with the Clinical Genetics Software of Genetico (CGS)
	LabConnect will be integrated with the CGS to send and receive the following information – • digital Test Requisition Form (dTRF) will be sent from CSG to LabConnect
	 Test report will be sent from LabConnect to the CGS Various time-stamp parameters such as the date on which sample was drawn and received by the Cytogenetic Lab, Sample ID generated in LabConnect, etc.

2.	Refer Test from the CGS
	For every case, the clinician can order one or more tests from a list of test that has been pre-configured in the CGS. Here, the priority (<i>Routine</i> or <i>Urgent</i>) can also be assigned for the sample by the clinician which will reflect in LabConnect.

4.	Sample Tracking Dashboard in CGS
	In the Sample Tracking Dashboard, a Phlebotomist/ user can search for a patient which has been referred for a test by a clinician through the CGS. On clicking a record, the dTRF will open which will contain the barcode to be printed along with other patient details.
	The browser will have the following column headers – Name, PID, UHID, Sample ID, Sample Collection Date, Sample Received Date, Sample Priority, Test Name, Sample Status. User can print a barcode for the sample and paste it on the sample container.

5.	Sample Received Confirmation in LabConnect
	When a sample arrives at the lab, the user scans the barcode and perform the <i>Receive</i> action to confirm its arrival. This updates the status to <i>Sample Received</i> in Sample Tracking Dashboard in CGS as well on Sample Dashboard in LabConnect.
	If the bar code is not present, a LabConnect user can search the sample through the Patient ID, which will fetch the relevant patient details if the sample is referred from the CGS. A barcode is also generated, which can be placed on the slides.



Sample Registration in LabConnect

User can manually register a sample and add all relevant details for samples not referred from the CGS. This feature will also act as a fail-safe in the rare event if integration between CGS and LabConnect faces any

issue due to technical	issues or internet issues at the location where CGS is
active.	

7.	Report Uploading in LabConnect
	There will be a button to upload the report for a particular sample and button to send the report to CGS. This report will then reflect in the Sample Tracking Dashboard and in the record of that patient in CGS.

8.	Sample Storage in LabConnect
	In the LabConnect, user can define <i>Sample Storage</i> options and assign for each sample.

9.	Report Download
	Clinicians can download the reports in the CGS. The reports can also downloaded by the lab team in LabConnect.

10.	Appointment System
	In the appointment module of CGS, a user can define available slots ar assign appointments to patients based on the available slots.
