Technical Specifications for Nephelometer (1 No.)

S.No	Specifications
1.	System should be a bench top model for rapid quantitative measurements of proteins in blood and urine samples.
2.	System should have atleast 27 parameters as mentioned below: HbA1C, IgA, IgG, IgM, Albumin, Prealbumin, A1 Acid Glycoprotein, Transferrin, Haptoglobin, Ceruloplasmin, Antithrombin, ASO, RF, CRP, Ultra Sensitive CRP, C3, C4, C1 Inactivator, α 1 Macroglobulin, Apo A1, Apo B, κ Light Chain, λ Light Chain, Urine Microglobulin, β 2 microglobulin and Cystatin C.
3.	Results should be reported in less than 2 minutes time.
4.	System should have a magnetic card enabling a batch specific calibration curve to be loaded into the instrument
5.	Blank measurement should be automatically processed in the same cuvette.
6.	Latex-enhanced immunonephelometric assays can be performed.
7.	System should be Calibrated against the International Reference Material CRM470.
8.	Electronic Pipette with dilution mode should be provided.
9.	Ready to use reagents, Including the latex antiserum.
10.	System should have temperature controlled reaction chamber.
11.	Operating Temperature range should be 15-30°C.
12.	The light Source should be Diode laser.
13.	System should have thermal inbuilt printer.
14.	Warranty as per AIIMS rules.

Firm should submit the following:

- Price Reasonability Certificate. Copy/ies of the supply order/s of the government/reputed private hospital/s for price justification.
- A copy of the satisfactory performance report of the quoted model from the user department should also be provided.
- An undertaking on the letterhead that the firm has not been blacklisted and has no vigilance case pending against them.

TERMS AND CONDITIONS:

- 1) Only authorized distributors should submit the quote and recent authorization letter must be provided.
- 2) The total/combined prices of all the items will be considered as the final price quote for price comparison purposes.
- 3) The quantity can be increased or decreased as per requirement.
- 4) The firm must be registered and having TIN no./Registration no. Please mentioned TIN/ registration no. on the bid or else the quotation will be treated as cancelled.
- 5) The make/model of the article offered should invariably be quoted. Quotation should be typed/ written in ink. No overwriting or erased entries should be there in the quotation. The rate should be valid at least one Month from the date of opening of quotations.
- 6) VAT/ Sales tax or any other kind of tax(s) must be mentioned separately as applicable on the item. In case no sales tax is chargeable, prices must be quoted as NET price.
