All over writing and erased entries will be deleted from the quotations. The rates should be valid at least for one year.

The tenders are required to deposit security of Rs. 5,000/-through a Demand Draft/Pay order drawn in favour of the AIIMS, CNC, Accounts, New Delhi-29, before submission of the quotations, failing which the same will not be considered. 
### Technical specifications for Mycoplasma Detection Kit

1. Kit should be able to detect contamination from live cells, fixed cells and culture media.
2. Kit should be PCR based for detection of mycoplasma.
3. Should be able to detect all common mollicute contaminations Mycoplasma, Acholeplasma, Entomoplasma and Spiroplasma.
4. Detects limit should not be  $> 5.10^2$ - $5.10^5$  cfu/ml mycoplasmas.
5. Storage conditions should be  $4\pm 8^\circ\text{C}$ .
6. Internal controls, major test requirements should be produced along with the kit.
