
The quoted items having quality mark such as I.S.I/C.E. mark/ISO9002 Standardization should be mentioned if any.

### **Specification for OCT compound for Cryostat (18 nos.)**


1. The OCT compound should be pure formation of water- soluble glycols and resin.
2. It should be convenient specimen matrix for cryostat sectioning at temperature of (-10°C) and below.
3. Minimum quantity of each reagent 100 ml.
4. It should not leave residue on side during staining procedure, eliminating undesirable background staining.
5. It should be developed and optimized for chromogenic IHC experiments.
6. Firms may be asked to submit a free of sample for testing purpose if required. If the firm fails to supply the OCT compound sample for test purpose they are not considered.
7. The price should be quoted in Indian rupees only.
