Further, in case of non-supply of material within the due date i.e. within the date of delivery, the Head, Department of Reproductive Biology, AIIMS, New Delhi will also have the right to impose penalty like forfeiture of performance security and removal of the name from the list of

the contractor for minimum 02 years and resort to risk purchase in full or part thereof at his /her direction. His/ her decision shall be final and binding.

- d) In case of default institute will have the right to procure the ordered item from open market / another party at their own risk and expenses under risk purchase clause, under this clause, the extra paid amount will be recovered from the 1st lowest firm, who is liable to supply the goods.
- 6. Handwritten quotations shall be accepted at the bidder's risk. In case of any discrepancy in the figures, the rate mentioned in words only will be considered.
- 7. Each tender should be accompanied with an EMD/BID Security amounting to Rs. 5000/- by way of FDR/Demand draft drawn in favour of "THE DIRECTOR AIIMS, NEW DELHI" failing which the tender shall not be considered for acceptance and will be outrightly rejected. Cash / cheque is not acceptable at all. SUCCESSFUL BIDDER WILL HAVE TO SUBMIT 10% performance SECURITY (OF TOTAL CONTRACT AMOUNT) BY WAY OF FDR/ DEMAND DRAFT DRAWN IN FAVOUR OF "THE DIRECTOR AIIMS, NEW DELHI" valid up to warranty period plus 3 months more from the date of letter of acceptance, failing which administrative action like debarring of approved firm for minimum of 38 months for participating in future tenders and forfeiture of EMD/BID security at AIIMS shall be taken. THE EMD/ BID SECURITY AND PERFORMANCE SECURITY DEPOSITED AGAINST OTHER TENDERS CANNOT BE ADJUSTED OR CONSIDERED FOR THIS LIMITED TENDER.
- 8. The Head, Department of Reproductive Biology, AIIMS, New Delhi shall be the final authority to reject in full or any part of the supply which is not conforming to the specification and other terms and conditions.
- 9. No payment shall be made for rejected material. The supplier should remove rejected items within one week of the date of rejection at their own cost & replace immediately. In case these are not removed, these will be disposed off in a manner deemed fit by the authorities at the risk and responsibility of the suppliers without any further notice.
- 10. The firm should submit an undertaking on firm's letterhead that it has not been blacklisted in the past by any government /private institution and there is no Vigilance/CBI case pending against the firm / supplier.
- 11. The quantity shown in the tender can be <u>increased</u> or <u>decreased</u> to any extent depending upon the actual requirement.
- 12. The firm must quote rates including freight, insurance, cartage, labor charge & other taxes etc. on FOB, AIIMS, New Delhi basis.
- 13. If required, the firm should be able to give demonstration of the item within one week of requisition. In case bidder fails to give demonstration strictly in accordance with tender specifications, administrative action shall be taken like forfeiture of PBG & debarring of firm for minimum 02 years at AIIMS. The counter offer shall be given to L-2 bidder to match the L-1 price and to supply the item as per tender terms.

- 14. The court of Delhi will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other than the Delhi court shall have jurisdiction in the matter.
- 15. Tender by Tele-fax /telegram /fax/e-mail will not be accepted.

#### 16. Fall Clause:

"The price charged for the Stores/equipments, under the reference by the supplier shall in no event exceed the lowest price at which the supplier has supplied the Store/equipment of same identical description to any other person /organization/ Institution during the current financial year. If at any time, during the said period, the supplier reduced the said prices of such Stores/equipments or sell such Store to any other person /organization /institution at price lower than the chargeable, he shall forthwith notify such reduction or sale to the **Head, Department of Reproductive Biology, AIIMS, New Delhi - 110029** and the price payable for the Stores supplied after the date of coming into force of such reduction or sale shall stand correspondingly reduced".

### **Specification of Weighing Balance – Quantity: 1**

- 1. It should have a higher weighing capacity of at-least 120 gm with minimum readability of 0.01 mg, repeatability  $\leq \pm 0.04$  mg and linearity  $\leq \pm 0.1$  mg.
- 2. It should have lower weighing capacity of at-least 3 mg with minimum readability of 0.01 mg, repeatability  $\leq \pm 0.04$  mg and linearity  $\leq \pm 0.1$  mg.
- 3. Its outer dimensions (D x W x H) should not be more than 380 x 220 x 320 mm.
- 4. It should come with minimum pan size of diameter 80 mm.
- 5. It should be with APC features i.e monitoring of compliance with the USP minimum sample weight limits (SQmin).
- 6. It should be of removable glass draft shields.
- 7. The balance must be made up of high-quality, durable materials that can be cleaned using a damp cloth or a standard cleaning agent.
- 8. It should be with taring and zeroing option.
- 9. It should come with the feature of password protection of set-up setting.
- 10. It should be with fully automatic temperature- and time-controlled internal calibration and adjustment.
- 11. It should have levelling intelligent, optoelectronic leveling sensor with alarm function and interactive user guidance for reliable leveling.
- 12. It should come with various selectable weight units such as kilogram, gram, milligram etc.
- 13. It should be enabled for direct data transfer to Microsoft® Windows programs through USB based mini interface without any third party software.
- 14. It should be with display touch screen with graphical user interface that can be optimized for users.
- 15. It should be with chemical resistant finish of the housing.
- 16. It should be with protective dust cover.
