1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of guoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

- 1. The seat shell shall be a welded assembly of seat, back and side fram e.
- 2. The seat and back shall be made of  $0.12\pm0.013$ cm thick CR steel shee t with oblong perforations. They shall be welded to side frame of size 32 mm x 5 mm thick HR steel.
- 3. The welded assembly shall be powder coated (DFT 40-60 microns).
- 4. The seat shall has a front water fall edge to provide popliteal clearanc e for comfortable seating.
- 5. It also shall has a buttock support curve that not only provides rear s upport but also prevents small children from falling through the gap b etween seat and back. Clean and flat surfaces of seat and back shall a ids in easy maintenance.
- 6. The dimensions of seat shall be 50 cm (W) x 44.5 cm (D) and of back s hall be 50 cm (W) x 40 cm (H).

- 11. The shoes fitted to leg assembly shall help in aligning the structure f or back to back arrangements. Levelers should take care of uneven flo oring .
- 12. Connecting beam shall be fitted with snap locking end cap. It also aid s in side-by-side under structure alignment.
- **13.** Armrest assembly shall consists of armrest frame and armrest.
- 14. The armrest frame shall be made up of size 31.7 mm x 4.7 mm thick H R steel and it shall be powder coated (DFT 4060 microns).
- 15. Overall Dimensions shall be Seat Height 40.5 cm, Height 77 cm.
